PRODUCT DESCRIPTION

FIRESAFE circular cable conduit has been tested and developed for use in fire resistance class **EI 60** to **EI 120**.

FIRESAFE circular cable conduit is a system that allows installation of new cables later.

FIRESAFE circular cable conduit is made of 1.5 mm thick white powder-coated steel. The cable conduit is fitted internally with an intumescent laminate in each end of the conduit, that quickly closes the penetration in the event of a fire. In addition, FIRESAFE circular cable conduit contains a circular cold-smoke seal of 100 mm stone wool in the middle of the conduit.

Cable conduit Ø70. Outside dimension: Ø76 mm. Inside dimension: Ø68 mm. Cable conduit Ø50. Outside dimension: Ø52 mm. Inside dimension: Ø43 mm. Cable conduit Ø30. Outside dimension: Ø32 mm. Inside dimension: Ø24 mm.

Cable conduits Ø30, Ø50 and Ø70 mm are available in length 330mm.

AREAS OF USE

Fire classified floors according to EN 1363-1: Coatings / molded covers (density 600 - 650 kg/m³) \ge 150mm.

Fire-classified walls according to EN 1363-1: Plasterboard or masonry / cast construction (density $600 - 650 \text{ kg/m}^3$) $\geq 100 \text{mm}$.

FIRESAFE circular cable conduit is used in combination with FIRESAFE GPG MORTAR in multiple or single penetrations.

Circular cable conduit can be used with all types of electric cable and telecom cables with a diameter of \leq 21 mm, and with plastic electrical cable conduits with a diameter of \leq 32 mm, or it can remain empty for later use. However, the cold-smoke seal must be in place at all times.

INSTALLATION OF CABLE AND PLASTIC CABLE CONDUIT

FIRESAFE circular cable conduit contains a bag of stone wool for cold-smoke seal. When used the whole bag can be reinstalled into the cable conduit, or the stone wool can be removed from the bag and placed back into the conduit around the cables if necessary.

Make sure that the stone wool is compressed sufficiently for good cold-smoke seal.
